SchoolAdvisor in no way guarantees that this information is correct nor is it in anyway responsible for content or services provided on such third party suppliers.

For suppliers: there is a freemium model that incurs no monthly cost but there are also paid for options as set out in the in the Payment Terms.

PAYMENT TERMS AND PRICING FOR SCHOOL SUPPLIERS

School suppliers can choose from 3 listing options, as per the SchoolAdvisor 'pricing page' that can be found at (<u>https://schooladvisor.co.za/PricingTable/PricingTable</u>), when listing or claiming their business on the website. The options are 'Free', 'Country' or 'International'. Pricing and options will change from time to time but will always will be updated on the website. Fees/commissions are as per the following

- Monthly Listing Fees.
 - This fee does not apply to the 'Free' listing option and is only applicable to the 'Country' or International' listing option on the website. The 'Country' and 'International' fee is a monthly fee as per the pricing page
 - By accepting these terms and conditions you accept that you shall pay such fees on a monthly basis paid for the month in advance.
 - You agree that payments will be made to us via a debit order or a credit card payment automatically from your account.
 - Monthly listing fees are on a month to month contract and can be cancelled at anytime
 - <u>AUTOMATIC RENEWAL OF SUBSCRIPTION</u>; After your initial month subscription period, and again after any subsequent subscription period, your subscription will automatically continue for an additional month (each a "Renewal Term"), at the renewal price communicated to you at the time your purchased your initial subscription ("Renewal Price"), unless we provide you with at least thirty (30) days advance notice of a change in your Renewal Price. You agree that your account will be subject to this automatic renewal feature.
 - If you want to change or terminate your subscription, you can do so online through the website by downgrading to the free version.

 - The percentage can change but this will be communicated to you before accepting any new quote requests
 - SchoolAdvisor will contact you with a quote request from a school through the website or via an email or via a telephone call - you then decide if you want to accept the quote request.
 - In certain cases, you will be required to send us the quote directly and we will forward it to the school to make it easier for you and the school that is requesting the quote.
 - Quotes will be made out in the name of the school
 - In cases that you need interaction with the school to determine and provide a quote, you will be provided with the quote requesters contact details (we know that schools love personal interaction!).
 - If a school accepts your quote, you agree to pay SchoolAdvisor the 'Success Fee' commission. If the school does not move forward with your quote, you don't pay any fee for the lead or quote opportunity
 - SchoolAdvisor will invoice you for the 'Success Fee' and payment must be made within 30 days of you receiving the invoice.
 - In the case that you have paid the 'Success Fee' and the school cancels or returns your product/service or part of the product/service, you will receive a refund for that portion of the cancelled or returned product/service. Payment will be made within 30 days of you giving us proof that the product has be cancelled or returned. In certain cases SchoolAdvisor will ask the school for proof that the product or service was cancelled or returned, if they cannot provide the proof no refund will be given
 - If further quote requests come to you from the school directly and not through SchoolAdvisor you
 don't pay us a cent for a 'success fee'. You only pay us when we generate you business from quote
 requests sent to you by SchoolAdvisor.
 - In the case of quotes with long-term contracts, School Advisor's 'Success Fee' will be determined only by the quotes' value for the first 12 months. This is the total value in the quote for the first 12 months of the contract value
